- **Networking:** Connecting and empowering professional youth




This newsletter provides highlights of circular economy activities undertaken in 2025, global sustainability engagements, and other related initiatives.



## **CIRCULAR ECONOMY ACTIVITIES FOR 2025**

In 2025, Provident Green Club (PGC) advanced circular economy action through impactful programs focused on youth engagement, sustainability education, and environmental restoration.

- **Podcast Series:** PGC hosted sustainability-focused podcast sessions spotlighting circular economy practices, climate action, and waste-to-wealth solutions.
- **Sustainable Gardening:** Trainings promoted eco-friendly gardening, composting, and food security using recycled and organic materials.
- **Waste to Wealth Tote Bags:** We collected used clothes and transformed them into reusable shopping bags through our cooperative society.
- **Generation Green X (GGX):** GGX 1.0 and preparations for GGX 2.0 engaged young people in renewable energy, green innovation, and circular business models.
- **Town Hall Meetings & Trainings:** Community town halls and capacity-building sessions strengthened awareness, collaboration, and green skills development.
- **ABU Zaria Chapter & Tree Planting:** PGC launched its first university chapter at ABU Zaria, marked by a tree-planting exercise to promote environmental stewardship. PGC remains committed to scaling circular solutions for a greener future.

## Generation Green X (GGX) Conference & Mentorship Program



Successfully hosted the Generation Green X Conference, a flagship youth sustainability event that empowered young innovators to develop eco-solutions.

Following the conference, 10 outstanding mentees were selected for an ongoing mentorship and incubation program, supported by experts and partners in the renewable energy and sustainability sectors.

# GLOBAL SUSTAINABILITY ACTIVITIES

## ● **Global Plastic Treaty Negotiations (UNEP)**

Countries continue negotiating a \*legally binding Global Plastics Treaty\* to end plastic pollution by 2040. Focus areas include phasing out harmful polymers, redesigning packaging, and boosting recycling infrastructure worldwide.

## ● **COP29 Climate Finance Negotiations**

The UNFCCC process is now focused on

- The New Collective Quantified Goal (NCQG) on climate finance,
- Expanding adaptation funds and strengthening climate transparency frameworks for all countries.

## ● **EU Corporate Sustainability Due Diligence Directive (CSDDD)**

The European Union is requiring large companies to:

- Assess environmental and human-rights risks,
- Reduce emissions across supply chains, and
- Adopt transition plans aligned with net-zero by 2050 diversity and sequestering carbon.



## ● Accelerated Renewable Energy Deployment

2024 recorded the highest addition of renewable energy in history. In 2025, countries are rapidly scaling:

- Offshore wind farms,
- large-scale solar parks,
- Hydrogen hubs,
- Grid modernization projects.

## ● Global Climate Adaptation and Resilience Efforts

Many countries are launching adaptation programs:

- Heat-resilient urban planning,
- Flood mitigation systems,
- Climate-resilient agriculture,
- Drought-resistant crop programs.

## ● Corporate ESG Strengthening and Mandatory Reporting

Countries such as the U.S., UK, and EU are tightening mandatory sustainability disclosures. Companies are reporting on:

- Climate risks,
- Biodiversity impacts,
- Gender equality,
- Social governance,
- Supply chain transparency.



## ● Blue Economy Expansion

Nations are investing in sustainable ocean sectors:

- Marine conservation,
- Offshore renewable energy,
- Sustainable fisheries,
- Eco-friendly coastal tourism,
- Blue carbon ecosystems (seagrass, mangroves).

- **Nature Restoration Law (European Union)**

**The EU adopted the \*Nature Restoration Law\*, which obligates member states to restore degraded ecosystems, wetlands, forests, and pollinator populations by 2030.**



- **Global Methane Pledge Implementation**

Over 150 countries are now implementing the pledge to \*reduce methane emissions by 30% by 2030\*, focusing on oil & gas leaks, agriculture, and waste management.

- **UN Decade on Ecosystem Restoration (2021–2030)**

Governments, NGOs, and private sectors are increasing restoration projects for:

- mangroves,
- drylands,
- freshwater ecosystems,
- degraded farmlands.

Billions of dollars in restoration finance have been mobilized.

- **Youth and Climate Innovation Programs)**

Global youth climate hubs and accelerators are growing, supporting:

- Green entrepreneurship,
- Climate tech innovation,
- Environmental leadership



- **Sustainable Cities and Green Infrastructure**

Global cities are rolling out:

- Green buildings codes,
- Renewable-powered transit,
- Zero-emission bus fleets,
- Low-emission zones,
- Smart waste collection systems.

- **Carbon Markets, Carbon Credits & MRV Expansion**

More nations and corporations are:

- Joining carbon markets,
- Implementing digital MRV tools,
- Investing in verifiable climate projects,
- Adopting internal carbon pricing.

- **Responsible Mining and Critical Minerals Governance**

With rising demand for batteries, countries are adopting stricter frameworks for:

- Ethical lithium and cobalt sourcing,
- Eco-efficient extraction technologies,
- Circular metals recycling.

- **Global Food Systems Transformation**

International organizations are investing in sustainable agriculture through Regenerative farming, Precision agriculture technologies, Reduction of food loss and waste, Climate-smart irrigation systems.



## WORLD AND GLOBAL ENVIRONMENTAL DAYS CELEBRATIONS

The Provident Green Club (PGC) has consistently observed and actively participated in key global environmental events to raise awareness, engage members, and inspire collective action. Highlights include:



**World Environment Day (June 5):**  
Campaigns and community clean-ups promoting biodiversity and sustainable living.



**World Wildlife Day (March 3):**  
Programs highlighting biodiversity protection and wildlife conservation.



**International Day of Forests (March 21):** Tree planting activities and educational sessions on forest conservation.



**Global Recycling Day (March 18):**  
Advocacy for waste segregation, recycling, and circular economy practices.



**Earth Day (April 22):** Workshops and awareness drives on climate action and responsible consumption.



**International Day for Biological Diversity (May 22):** Educational activities on the importance of biodiversity and ecosystem protection.



**World Water Day (March 22):**  
Initiatives on water conservation, sanitation, and sustainable usage.



**World Energy Conservation Day (December 14):** Awareness campaigns on energy efficiency, renewable energy, and sustainable practices.

# Sustainability in Nigeria 2025: Progress in Motion

This year has been a powerful turning point for sustainability in Nigeria, as climate action moved from conversation to visible movement.

Across the country, students, businesses, researchers and communities are stepping into climate leadership, proving that environmental awareness is not a trend but a growing national priority.

From Lagos to Abuja, major events in 2025 have sparked collaboration and innovation around green practices.

In May, the ESG Summit and Awards in Lagos spotlighted “Green Innovation, Climate Policy and Nigeria’s Green Transition”, bringing together environmental advocates, policymakers and private-sector leaders to explore low-carbon growth and carbon markets.

The momentum continued in June when campuses under the Nigerian Conservation Foundation (NCF) led nationwide initiatives for World Environment Day, focusing on plastic-free campuses and waste-reduction strategies.



August brought another major milestone; the International Conference on Biodiversity, Ecology and Climate Change in Abuja; provided a platform for young researchers and environmentalists to present work, discuss solutions and build networks for climate resilience.

Most recently, the Nigerian Environmental Summit (NESt) 2025 gathered stakeholders from industry, government and civil society to discuss how to unlock Nigeria's green economy and build environmentally responsible systems. These events show that the sustainability conversation is no longer niche, it is national.

The actions on ground are being matched with legal changes. In October, the National Assembly passed the Endangered Species Conservation and Protection Bill 2024, a landmark update to wildlife laws aimed at combating illegal trade in ivory, pangolin scales and other endangered species. The bill strengthens penalties, speeds up court processes and expands investigative powers to track financial flows linked to wildlife crimes.

Meanwhile, the Lagos State Government began enforcing a ban on certain single-use plastics (SUPs) from July 1, including styrofoam containers, thin bags, straws and plastic cutlery, to reduce plastic pollution and protect drainage systems and waterways.



These legal measures are not just statements of intent, they signal real commitment to protecting ecosystems, reducing waste and setting a greener course for Nigeria's future.

These developments are not just headlines, they are openings for action. As members of PGC we can help turn awareness into impact and champion sustainable alternatives in daily life.

Every small choice matters, from switching to reusable materials, to educating peers and families. The movement has already started. Let's make sustainability a lifestyle, not just a headline.
